# ARE YOU AN ASHE CERTIFIED HEALTH CARE PHYSICAL ENVIRONMENT WORKER?

Many health care organizations require ASHE certification in bid specifications. For contractors and subcontractors, earning the certification can help you land jobs because you will show employers you are ready to work in health care facilities. ASHE recommends that each general contractor/project lead hold a Certified Healthcare Construction (CHC) certification, and that at least one CHC should be part of every health care construction project. ASHE recommends that everyone else on a job site should be a Certified Health Care Physical Environment Worker. ASHE's certified worker program is unique because it is focused on patient safety and is the only certification of its kind backed by the American Hospital Association. Getting ASHE certified shows that you truly understand the complex health care physical environment.

ASHE is providing members of its affiliated chapters access to take the Certified Health Care Physical Environment Worker Exam, for the ASHE member rate of \$40 (non-member rate is \$50).

The Certified Health Care Physical Environment Worker Certification is a new way for workers to show that they are qualified to work in the complex health care physical environment. We all can agree that health care facilities are different from other job sites. They are highly regulated, operate around-the-clock, and house vulnerable patients. Everyone who works on a health care site -- from those doing a day of construction work to those with full-time positions in a hospital -- should understand the complex health care environment.

Upon successful completion of the exam, the participant will earn a temporary badge that can be printed to show they passed the exam. A permanent badge featuring their name and photo will be mailed to them. For those individuals who pass the exam, certification is valid for 3 years from the day they passed.

ASHE's certified worker certification is unique because it focuses on patient safety and is the only certification of its kind backed by the American Hospital Association. Getting ASHE certified shows an individual truly understands the complex health care physical environment. Chapter members who are interested will need to follow the below steps.
